Assistant Project Coordinator (Monitoring and Evaluation)

under "Resilient Homestead and Livelihood Support to the Vulnerable Coastal People of Bangladesh (RHL)" Project

1. Background

Palli Karma-Sahayak Foundation (PKSF), an apex development organization focusing on holistic and integrated approaches, was established by the Government of Bangladesh in May 1990 for sustainable poverty reduction through employment generation. At the beginning of its operations in 1990, with a view to generating employment for the rural poor, PKSF set the goal of creating self-employment opportunities in the rural off-farm sector and adopted the strategy of promoting loan programs to attain this goal. Over the years, PKSF has gained a thorough understanding and valuable experience with the multifaceted aspects of poverty and hence adopted human-centric development approach in 2010. Since then, PKSF has been implementing projects and programs in diversified sectors including sustainable enterprise, training and education, agriculture, climate change and disaster and so on. PKSF works with more than 15 million households through its 200 partner organizations. Many development partners, such as the World Bank, DFID, EU, ADB, IFAD, GIZ, GCF, and Adaptation Fund (AF) are working with PKSF. Please visit http://www.pksf.org.bd for details.

The geographical location and low elevation of the coastal zone of Bangladesh make it vulnerable to disasters. In contrast, climate change poses a new challenge to the lives and livelihoods in the coastal region. It is predicted that a 45 cm rise in sea level may inundate 10-15 percent of Bangladesh's land by the year 2050, resulting in 35 million climate migrants from the coastal districts. The vulnerability of these coastal people can be defined in three ways: climate-sensitive livelihoods; vulnerable settlements in low-lying areas; and scarcity of safe drinking water. Many coastal residents depend on seasonal subsistence agriculture and agriculture wage labour, which are highly climate sensitive. Moreover, many coastal inhabitants live in houses built of mud and plants which are severely affected by cyclones, storm surges, and high tides. The lack of climate-resilient housing poses a serious poverty trap as significant portions of the incomes of coastal communities go towards house repairs. Under this circumstance, to develop a climate-adaptive coastal community in Bangladesh by adopting climate-resilient housing and livelihood technologies, the Green Climate Fund (GCF) under the United Nations Framework Convention of Climate Change (UNFCCC) approved "Resilient Homestead and Livelihood Support to the Vulnerable Coastal People of Bangladesh (RHL)", a five-year project, in 36th GCF Board on July 14, 2023.

The Palli Karma-Sahayak Foundation (PKSF) will implement the project (for details about PKSF, please visit http://www.pksf.org.bd) as a Direct Access Entity (DAE) of GCF, an apex development organization under the Financial Institutions Division of the Ministry of Finance, with a budget of \$49.99 million. The project has chosen seven exposed coastal districts, namely Khulna, Bagerhat, Satkhira, Barguna, Patuakhali, Bhola, and Cox's Bazar, which are particularly vulnerable to sea level rise, salinity intrusion, coastal flooding, cyclones, and storm surges due to their geographical position.

The primary goal of the RHL project is to enhance the climate resilience of the vulnerable coastal communities of Bangladesh. The project will attain this goal by financing the development of climate-resilient housing and livelihood technologies while raising knowledge and awareness about the impacts of climate change. The project will build climate-resilient homesteads through the establishment of new, climate-resilient building codes. It will also develop adaptive livelihood options for highly vulnerable and women-headed households-fostering a safer and more resilient future for homes in coastal areas.
